# Day 1 - Friday, Jan. 9: Depart USA

Our tour begins as we depart on our overnight flight to Cairo, Egypt. Meals and drinks will be served on board.

### Day 2 - Saturday, Jan. 10: Arrive Cairo

Arrive at Cairo International Airport. Meet and assist by your tour representative. Transfer to your hotel. Dinner and overnight in Cairo. (D)



Day 3 - Sunday, Jan. 11: Cairo

Breakfast at the hotel. Explore the Great Pyramids and the iconic Sphinx at the Giza Plateau. Visit the Step Pyramid of Djoser in Sakkara — the world's first monumental stone building. Continue to the ancient city of Memphis, the first capital of unified Egypt. Dinner and overnight in Cairo. (B/D)




Day 4 - Monday, Jan. 12: Cairo / Luxor

Breakfast at the hotel. Fly to Luxor – known as the world's largest open-air museum. Upon arrival, visit the majestic Karnak Temple. Embark on your Nile Cruise before lunch. In the evening, visit Luxor Temple, beautifully illuminated at night. Dinner and overnight on board our Nile cruise. (B/L/D)



Day 5 - Tuesday, Jan. 13: Luxor - Valley of the Kings

Breakfast on board. Cross to the West Bank to explore the Valley of the Kings (visit 3 elaborately decorated tombs), the Temple of Queen Hatshepsut at Deir el-Bahari, and the Colossi of Memnon. Return to the cruise and begin sailing to Edfu. Lunch, dinner, and overnight on board our Nile cruise. (B/L/D)



Day 6 - Wednesday, Jan. 14: Edfu / Kom Ombo

Breakfast on board. Visit the Temple of Horus in Edfu by horse-drawn carriage. Sail to Kom Ombo. Visit the unique twin temple of Kom Ombo, dedicated to Sobek and Horus. Dinner and overnight on board our Nile cruise. (B/L/D)



Day 7 - Thursday, Jan. 15: Aswan - Elephantine Island & Philae Temple

Breakfast on board. Visit Elephantine Island by boat and explore early Christian ruins including the remains of the Monastery of St. Simeon and ancient churches. Continue to Philae Temple and view the High Dam of Aswan. Return to our Nile cruise for dinner and our final overnight on board. (B/L/D)




Day 8 - Friday, Jan. 16: Aswan / Cairo

Enjoy breakfast on board our Nile cruise before disembarking. Fly to Cairo. Upon arrival in Cairo visit the new Grand Egyptian Museum – the largest archaeological museum in the world. Continue to the Coptic Museum to explore its rare Christian antiquities, manuscripts, and icons. Dinner and overnight in Cairo. (B/D)

# Day 9 - Saturday, Jan. 17: Cairo

Breakfast at the hotel. Visit Old Cairo churches, including the Hanging Church, St. Sergius & Bacchus Church (where the Holy Family is believed to have stayed), and Ben Ezra Synagogue. Visit the Old Egyptian Museum featuring the treasures of King Tut. Dinner and overnight in Cairo. (B/D)



Day 10 - Sunday, Jan. 18: Cairo / USA
Breakfast at the hotel. Transfer to Cairo Airport for our return flight home.

#### **GENERAL INFORMATION AND CONDITIONS**

**Reservations and Payment:** Please complete the attached Reservation Application and return it with your deposit of \$300.00 per person at the time of booking. Final payment is due 65 days prior to departure.

Cancellations: All cancellations must be in writing. Cancellations received after 5PM Pacific Time or on weekends/holidays will be processed the next business day. The following per person cancellation charges will apply: If canceled 91 days or more prior to departure, a \$50.00 administrative fee will be charged. If canceled 90 - 61 days prior to departure, \$250.00 will be charged. If canceled 60 - 31 days prior to departure, \$450.00 will be charged. If canceled 30 - 7 days prior to departure \$700.00 will be charged. No refunds will be made within 6 days of departure. In addition, once the airline tickets have been issued, 100% of the airfare is non-refundable unless you have been advised otherwise at the time of your booking. Additional cancellation charges may apply depending upon the cancellation terms of our suppliers.

**Refunds**: Subject to the foregoing Cancellation Terms, upon cancellation of travel related services, all sums paid to George's International Tours for such services will be promptly returned to the passenger, provided the passenger is not in violation of any of the terms and conditions previously, clearly and conspicuously disclosed and agreed to by the passenger. This refund provision does not apply where George's International Tours has remitted the payment to another registered seller of travel or a carrier and they default in providing the agreed-upon transportation or service without providing a refund. In such a situation, George's International Tours agrees to provide passenger with a written statement accompanied by a copy of the bank records establishing the disbursement of the payment, and if disbursed to a seller of travel, proof of their current registration.

**Trust Account Disclosure:** California law requires certain sellers of travel to have a trust account or bond. George's International Tours has such a trust account.

Travel Consumer Restitution Corporation ("TCRC"): George's International Tours is a participant in the Travel Consumer Restitution Corporation ("TCRC"). You, the passenger, may request reimbursement from TCRC if the Seller of Travel was registered and participating in the TCRC at the time of sale and the passenger is located in California at the time of payment. Please be advised that passengers purchasing from outside of California are not covered by the TCRC. Eligible passengers may file a claim with TCRC if the passenger is owed a refund of more than \$50 for transportation or travel services which the Seller of Travel failed to forward to a proper provider or if such money was not refunded to you when required. The maximum amount which may be paid by the TCRC to any one passenger is the total amount paid on behalf of the passenger to the Seller of Travel, not to exceed \$15,000. A claim must be submitted to the TCRC within six months after the scheduled completion date of the travel. A claim must include sufficient information and documentation to prove your claim and a \$35 processing fee. You must agree to waive your right to other civil remedies against a registered participating Seller of Travel for matters arising out of a sale for which you file a claim with the TCRC, if you were located in California at the time of the sale. You may request a claim form by writing to: Travel Consumer Restitution Corporation, P.O. Box 6001, Larkspur, CA 94977-6001; or by faxing a request to 415-927-7698.

**Travel Documents:** A passport which is valid for a minimum of 6 months past the date of your return flight home is required of all U.S. citizens. Visas are required for U.S. citizens and can be obtained upon arrival in Egypt for a fee of approximately \$25.00. If you are not a U.S. citizen, please call to determine your visa requirement status. George's International Tours is not responsible for individual visas or passports.

**Tour Cost**: All quoted prices are based upon airfares, tariffs and currency exchange rates at the time of printing and are subject to change at any time. Should the minimum number of 20 tour members not be reached, the right is reserved to increase the tour cost accordingly.

**Tour Documents and Tickets:** Final tour documents are mailed, provided we have received full payment, within 3 weeks of departure.

**Baggage**: Each passenger is allowed one checked bag and one carry-on. You will be responsible for paying to the airline any additional charges for additional checked baggage or overweight baggage (if excess weight is permitted). George's International Tours is not responsible for lost, damaged or stolen baggage.

**Air Transportation:** Airfare is in economy class on British Airways (or any other IATA carrier). Fares are based upon levels in effect at the time of printing and fares/flight schedules are subject to change without notice.

**Hotels:** Accommodations are based on double occupancy rooms. A limited number of single rooms are available at the supplement quoted, and should be requested at the time of booking.

**Travel Insurance**: We strongly recommend that you have comprehensive travel insurance.
